Anthogs Showcase/Sell Membership Sign Up Agreement

U.S Only (50 United States including Washington DC)

- You agree that you are +18 years of age and are responsible for all the terms and conditions of this agreement.
- If under 18 years of age (age 17-13 Only), you and your parent/legal guardians' information provided agree you are responsible for all the terms and conditions of this agreement. A parent or legal guardians Drivers License Number or State Issued ID Number will be required.
- Under 13 years of age is forbidden in signing a Membership.
- *All Exhibits Showcased / Sell must only be available to sell at Anthogs Productions. Members/Sellers cannot sell or advertise their Exhibits being displayed on our website in any manner at all, in any fashion at all, in any way at all outside of Anthogs Productions (unless licensed by Anthogs Productions).
- You agree that All Art Genre, Handicraft's, and eBook/Book Exhibits (Physical and Digital) that you Showcase or have for Sale must be genuine and originally created/written and made by You (Member/Seller of Anthogs Productions). Any misinformation or deviation or fraud or copied work could subject you to be kicked off Anthogs Productions website and banned forever without any Membership refund an addition to any criminal or legal actions against you. Anthogs Productions is cleared from any wrongdoing, and you are the sole responsible person.
- Anthogs Productions has the right to remove your Membership, ban any Members/Customers/Users from using our website for anything that may be deemed offensive, abusive, or fraudulent at our discretion without refund and permanently banned from our website. If necessary, even contact local authorities.
Examples that may be deemed offensive: Any Exhibit images displayed, Language; User Profiles including Names, Photos, Aliases etc. that are viewed as Violence, Terrorism/violent extremism, Child sexual exploitation, Discrimination of any kind against race, ethnicity, national origin, caste, disability, sex orientation, gender, gender identity, religious affiliation, age.
- Anthogs Productions has the right to refuse service.
- Members/Sellers and Buyers who have 2 or more: refund requests, disputes, Member/Seller and Buyer disputes, Complaints, can result to suspension and/or permanent removal from Anthogs Productions.
- You (the Author/Creator) are responsible for policing and holding those accountable who have Copied, Sold, or otherwise used without your express permission.
- \$25 Annual Membership Options (No refunds after sign up): Showcase/Sell always up to 3 Exhibits for one year. If you Sell an Exhibit, you can replace it with another Exhibit as long as you always have up to 3 Exhibits to Showcase/Sell for one year.
- Exhibits Sold: *After Payment Processing Fees are taken out* Member/Seller will receive 90% of their Exhibits Sold and Anthogs Productions will receive 10% of all Exhibits/Books/eBooks sold.
- You the Member/Seller are 100% responsible for Shipping (including shipping return label) and Paying for Shipping on all Physical Exhibits to the Buyer. We highly recommend inserting your shipping cost in the price you set for your Exhibits. Use the following formula as guidance when setting your price: $(\text{Time} + \text{Material} + \text{ProfitMargin} + \text{Shipping} = X)$ For Example: $\$15\text{hr} + \$2 + 50\% + \$6 = \32 (Round off to the nearest dollar). \$20 minimum for all Physical Art Genres and HandiCraft Exhibits. Don't devalue your work, so please only use this price formula as guidance.
- *Highly Recommended: Consider registering and Copyright your work with the U.S Copyright Office. You (the Author/Creator) are responsible for policing and holding those accountable who have Copied, Sold, or otherwise used without your express permission. Anthogs Showcase/Sell Membership Sign Up Agreement – Cont'd

- Anthogs Membership Sign Up (\$25 Annual Showcase/Sell Memberships): Once you enter your information to sign up, you will be prompted to enter your payment information to be archived as well as other information for security authenticated protocol procedures which is why we chose Stripe. Showcase/Sell Membership Only Annual Membership price is \$25 and automatically renewed every year unless prompted by the Member/Seller to not renew. Once the Membership is paid for, it is non-refundable.
- Buyers who are wanting to purchase an Exhibit/s: They will select which Exhibit/s they would like to purchase and add to their cart and check out. Once the Buyer checks out, they will be prompted to enter their Payment information. The Buyer will be responsible for paying for the Exhibit cost and any Sales Tax incurred. Shipping is paid for by the Member/Seller. The funds will be processed immediately and will be held with Anthogs Productions for 7 Business Days (not including Stripe payment transaction days) and then released to the Members/Seller and Anthogs. The Buyers contact information and shipping location will be sent to the Member/Seller to fulfill the Exhibit order and ship within 3 business days to the Buyer. The Member/Seller will reach out to the Buyer and provide shipping details (including tracking number). It is highly recommended that the Member/Seller purchases shipping insurance in case of any mishaps.
- The Member/Seller provides a Return Label on all Physical Exhibit purchases, a required signature for delivery is also highly recommended. It is also highly recommended that all Physical Exhibits shipped have shipping insurance (especially if over \$500), so if the Exhibit was damaged by the Carrier, all parties should be resolved. **The Member/Seller should insert the costs of the Return Label and Shipping Insurance in their Exhibit Sale Price.**
- A full refund will be immediately provided to the Buyer within 5 business days after receipt of the Exhibit to the original Member/Seller (in the same condition it was shipped out unless damaged by the carrier). All Physical Exhibits shipped will have a Return Shipping Label included in case the Buyer is not satisfied. The Member/Seller is responsible for paying for return shipping.
- Anthogs Showcase/Sell Membership Payout on Exhibits: Members/Sellers will have 3 business days to ship out the Exhibit to the Buyer. Once the Buyer checks out, they will be prompted to enter their Payment information. The funds will be processed immediately and will be held with Anthogs Productions for 7 Business Days (not including Stripe payment transaction days). After a small payment processing fee percentage and any other potential costs are taken out, the total amount left remaining will be paid out in the following [90% of the amount is released to the Member/Seller you are buying the Exhibit/s from and 10% Admin Fee to Anthogs].
- Buyer and Member/Seller discrepancies; Returns/Refunds: All Physical Exhibits have a 7 day return policy upon delivery (required signature for delivery is highly recommended). **All Digital Exhibits** (including eBooks) are nonreturnable and nonrefundable (Except fraud is proven by your local authorities). All issues are to be handled directly by the Buyer and Member/Seller regarding their Exhibit/s. If the issue cannot be settled, please contact Exhibits@anthogs.com to serve as arbitrator. If after Anthogs has served as an arbitrator and either party is unhappy with the outcome, they may choose other alternatives, but Anthogs Productions is excluded from all disputes. However, the Buyer is responsible on ensuring that the Exhibit is returned to the Member/Seller as soon as possible whether the Buyer and/or Member/Seller pays for the shipping.
- Taxes: Taxes will be applied based on the shipping location the Exhibit will be shipped to. The Buyer will see the taxes included before submitting payment upon checkout. Due to Internal Revenue Service (IRS) regulations, US third-party settlement organizations and payment processors, including Anthogs Productions, are required to file a Form 1099-K for US taxpayer sellers who meet the following thresholds in a calendar year (royalties paid from January 1 through December 31).
*Note: Certain states have a lower reporting threshold compared to the federal levels. Consult with the IRS or your tax professional advisor to understand if your state qualifies.
- Taxes Continued: Anthogs Productions will make a copy of your form available to you on or before January 31 of the following year. If you did not consent to electronic delivery, the form will be postmarked on or before January 31 of the following year and will be mailed to the address provided by you. If you signed up for electronic delivery, your tax forms will be emailed to you by January 31.
- eBook Returns: eBooks are nonrefundable and nonreturnable (Except fraud is proven by your local authorities). All eBooks must at least be able to be read with Adobe Digital Editions [ADOBE DIGITAL EDITIONS Download](#) (or use PDF format).

Any breach of the following policies will result in a ban from our Anthogs website, cancellation and permanently banned of your Membership without any refund, and your local authorities contacted if any laws are violated.

Any disclosure of their personal information without the consent of the Member/Seller or Buyer, you are responsible for that unauthorized disclosure. Member/Seller or Buyer contact information received may only be used for Anthogs Production related communications or for Anthogs Productions Exhibit transactions.
- The Member/Seller or Buyer is prohibited from proactively contacting each other after Exhibit delivery completed, save any contact information outside of Anthogs Productions platform, or sell Members/Sellers or Buyers contact information, or send any promotions or advertisements or for any soliciting purposes per our privacy policy and U.S privacy laws. Or reach out to Member/Seller or Buyer on any social media platforms without authorized consent.

Handicraft's/Handcrafts

Handicraft: A particular skill of making decorative objects by hand.

A handicraft, sometimes more precisely expressed as artisanal handicraft or handmade, is any of a wide variety of types of work where useful and decorative objects are made completely by one's hand or by using only simple, non-automated related tools like scissors, carving implements, or hooks.

Art Genres and Handicraft's

Including eBook/Book

All Art Genre and Handicraft's and eBook/Book Exhibits that are Showcased or For Sale must be genuine and originally created and made by the person Showcasing/Selling the Art or Handicraft or eBook.

Art Genres: Different Genres of Art from Poetry, Modern Art, Pop Art, Contemporary Art, Literature, Music, Film, Painting, Sculpture, Ceramic Art, Clay Art, Graphic Art, Unique, etc

- Art Genres Accepted: The traditional subdivision of the Arts, being Architecture, Sculpture, Painting, Literature, Music, Performing, and Film.
- Including: Poetry, Abstract Art, Custom Art, Modern Art, Pop Art, Contemporary Art, Contemporary Art, Animation Art, Collage Art, Assemblage Art, Graphic Art, Ceramic Art, Clay Art, Conceptual Art, Drawing, Folk Art, Jewelry Art, Junk Art, Painting (Oils, Watercolors, Acrylics, and more), Photography, Calligraphy, eBook, Book (Hard Cover or Paperback).
- *Highly Recommended: Consider registering and Copyright your work with the U.S Copyright Office

Book/eBooks (Electronic Book) PDF or ePUB format

eBook: An **electronic book** (also called an e-book, ebook or digital book) is a book in digital form. E-books can be read on computers or other electronic devices such as e-book readers. E-book readers, such as the Amazon Kindle, the Kobo eReader and the Barnes and Noble Nook are devices which are dedicated to showing e-books.

E-book, in **full electronic book**, digital file containing a body of text and images suitable for distributing electronically and displaying on-screen in a manner similar to a printed book.

- *You must be the original author who wrote the book and must have an ISBN (International Standard Book Number) Number registered and located in your eBook/Book.
- *eBook format accepted only: PDF or ePUB format only
- All eBook ePUB format must at least be able to be read with Adobe Digital Editions [ADOBE DIGITAL EDITIONS Download](#) (or use PDF format).
- eBooks are nonrefundable and nonreturnable (except fraud is proven by your local authorities).
- Highly Recommended: Register your eBook through the U.S. Copyright Office. “Although a completed e-book is automatically copyright-protected, copyright registration and storage of the e-book with the U.S. Copyright Office provides the verification required for legal actions and qualifies the copyright owners for damages and legal fees.”
- You (the Author) are responsible for policing and holding those accountable who have Copied, Sold, or otherwise used without your express permission.
